Personal data

To sign up for an account your email address, a password and a username is needed. To make your next visit easier we install a cookie that remembers the email address you enter for yourself. FLOORPLANNER.COM stores this data for the term you make use of our services. Furthermore FLOORPLANNER.COM makes use of analytical cookies for improving its services (You can find more details on the cookies actually stored and used on this page).

Purpose

FLOORPLANNER.COM processes personal data for the purpose of (i) the performance of our contract with you for our Floorplanner and Roomstyler services and/or websites, and (ii) providing follow up on services (i.e. emails and newsletters) and your service requests.

FLOORPLANNER.COM does not sell or otherwise distribute your personal data to third parties and will not use your personal data for any other purposes than stated above. For the processing of payments we make use of a payment platform provider (Adyen).
